### **NOTICE OF PROPOSED MEMBERSHIP OF THE GOVERNING COUNCIL OF THE AFRICAN BAR ASSOCIATION**

On behalf of the Executive Council of the African Bar Association (AFBA), I write to inform you that at the meeting of the Executive Council held on the **10<sup>th</sup> day of August 2023 in Pretoria, Republic of South Africa**, it was proposed that you be admitted into membership of the Governing Council of the Association.

This proposal which is on the recommendation of the **Qualifications Committee** is sequel to your sterling qualities, Leadership abilities and meritorious services to the Legal Profession in Nigeria and the African Continent.

The Governing Council of AFBA is the highest organ of the Association led by a Chairman, a Vice Chairman and the Secretary who is also the Secretary-General of the Association, the AFBA Council sets policy decisions and takes vital steps in external issues. These decisions are partly implemented by Council itself and mainly by the Executive Council as enshrined in the **AFBA Charter 1975(as amended in 1995)**.

Membership of the Council must be registered members of the Association who are selected to help foster the interest of AFBA, develop the platform and make it a veritable instrument for Continental Legal engagement.

The Council members assist the Association to surmount numerous challenges and help foster a united African Legal fraternity.

Members of Council pay an annual membership fee of between Three Hundred Dollars (\$300) to One Thousand US Dollars (\$1,000) or its prevailing equivalent in local currency, this is beside yearly normal membership renewal of \$60. However, any Council Member that makes a contribution of One Thousand Dollars (\$1000) and above is exempted from paying conference fees for that year.

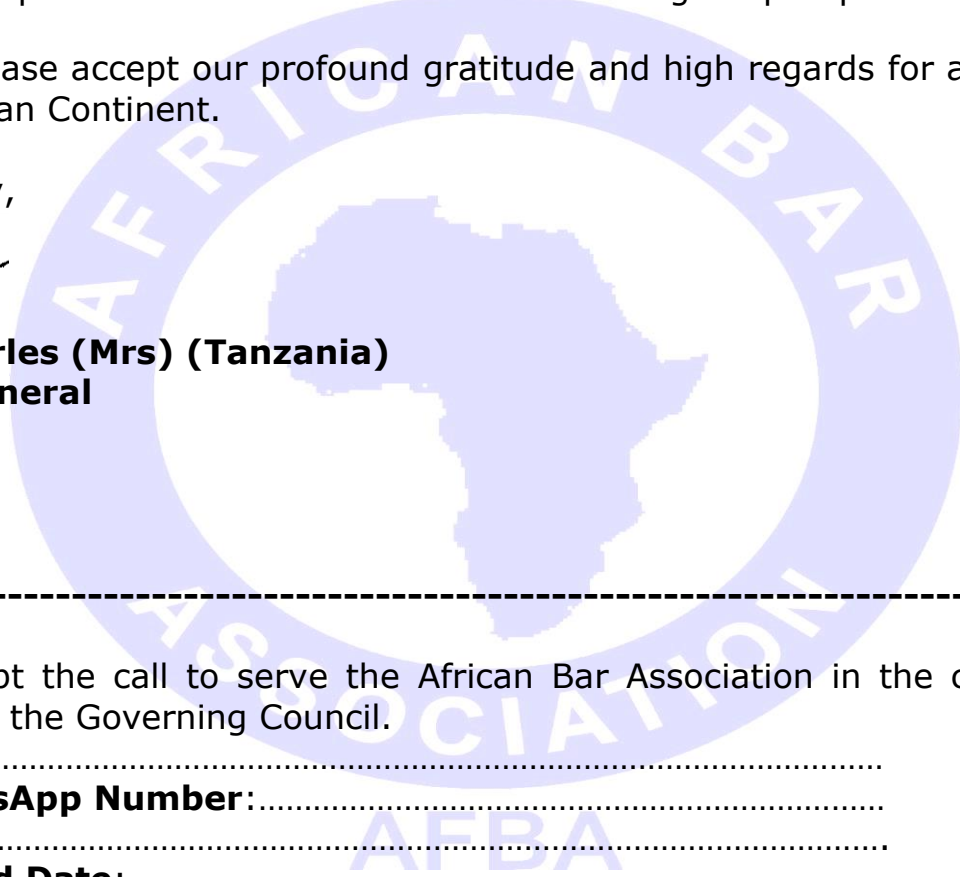
